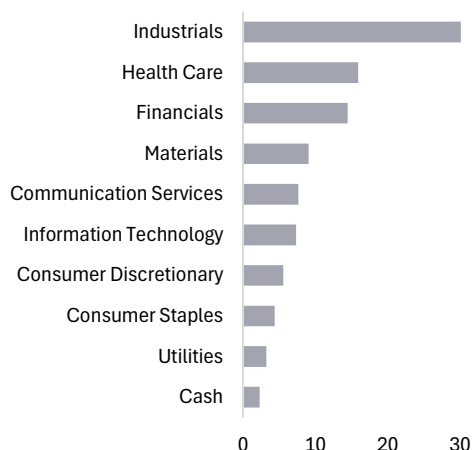

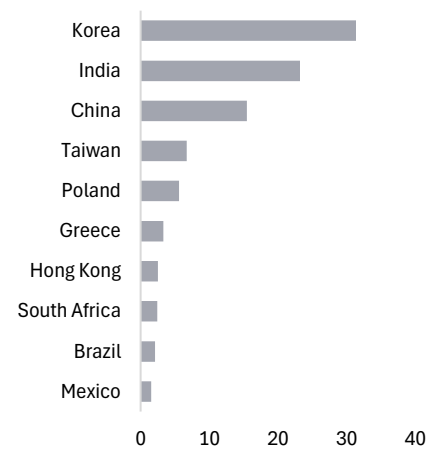

The MSCI Emerging Markets Value Index captures small cap securities exhibiting value style characteristics across 25 EM countries.
