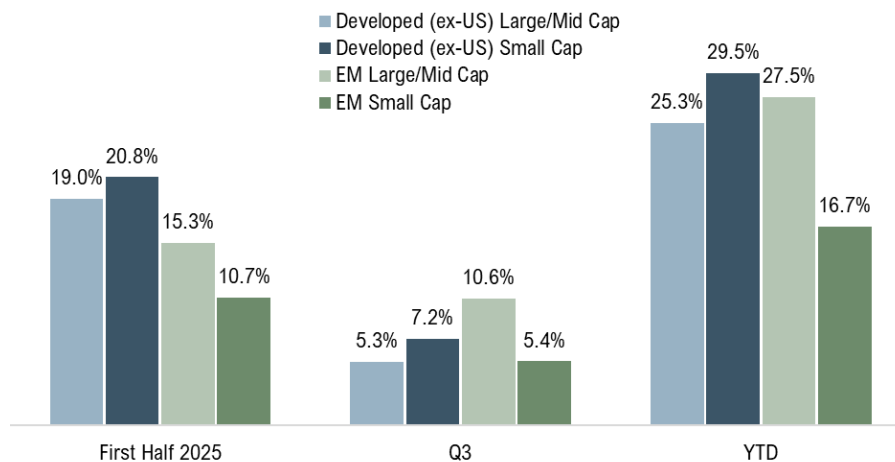

The IMC Emerging Markets Small Cap strategy gained 10.08% (net of fees) in the third quarter of 2025, outperforming its benchmark by 472 basis points. Informed Momentum (momentum exposure & stock selection) drove outperformance in the quarter, while exposure to volatility and relative industry positioning was further additive.

MARKET ENVIRONMENT

Global equities extended their gains in Q3 with AI as a dominant theme

- Strength in global equities continues to be underwritten by the AI buildout and everything it touches. The entire AI supply chain is now the dominant macro factor moving markets. Corporate earnings strength and a dovish pivot from the US Federal Reserve served to further boost risk appetite in Q3.
- Emerging markets were led by strong gains in China amid progress in US-China trade negotiations. Among developed markets, Japan outperformed as expectations for political reform lifted sentiment, while Canada and Australia benefited from commodities/precious metals tailwinds.
- The MSCI EM Index (large/mid cap) outperformed in Q3, gaining 10.6%, driven by its hefty exposure to China. The MSCI EM Small Cap Index finished the quarter up 5.4% with strong gains in China and Taiwan being offset by losses in India.



China led gains, while India continued its slide

In the MSCI EM Small Cap Index, China was the best-performing country in Q3, up 25.1%, propelled by strength in tech and AI names, and underpinned by signs of progress in US-China trade negotiations. On the other side, India continued to slide, falling 7.0% in the quarter, on tariff pressures and a lack of exposure to the AI-driven rally.

In EM small cap, all sectors ended the quarter positive, with technology as the standout, up 14.5%, followed by health care (+9.0%) and energy (+8.0%). Utilities (+0.4%) and consumer discretionary (+0.6%) failed to keep pace.

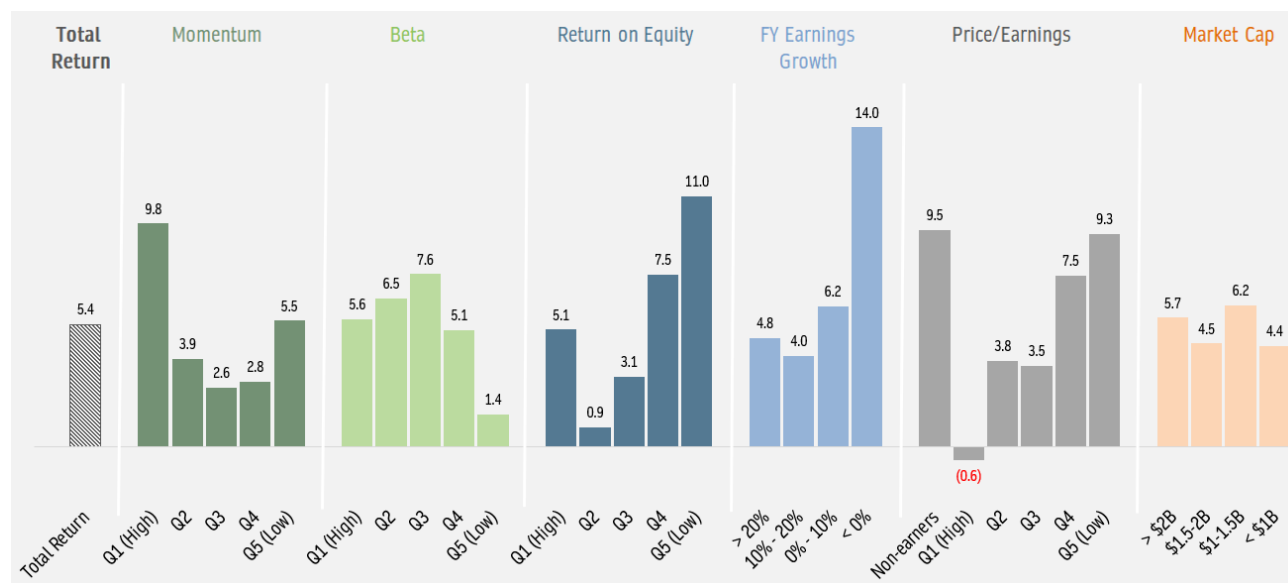

Momentum stocks outperformed

High momentum stocks outpaced the index in Q3 as the top quintile momentum bucket gained nearly 10%. Additionally, low-quality and value characteristics outperformed, as low ROE and negative earnings growth stocks were the best performers.

Q3 2025 Performance Drivers in the MSCI EM Small Cap Index



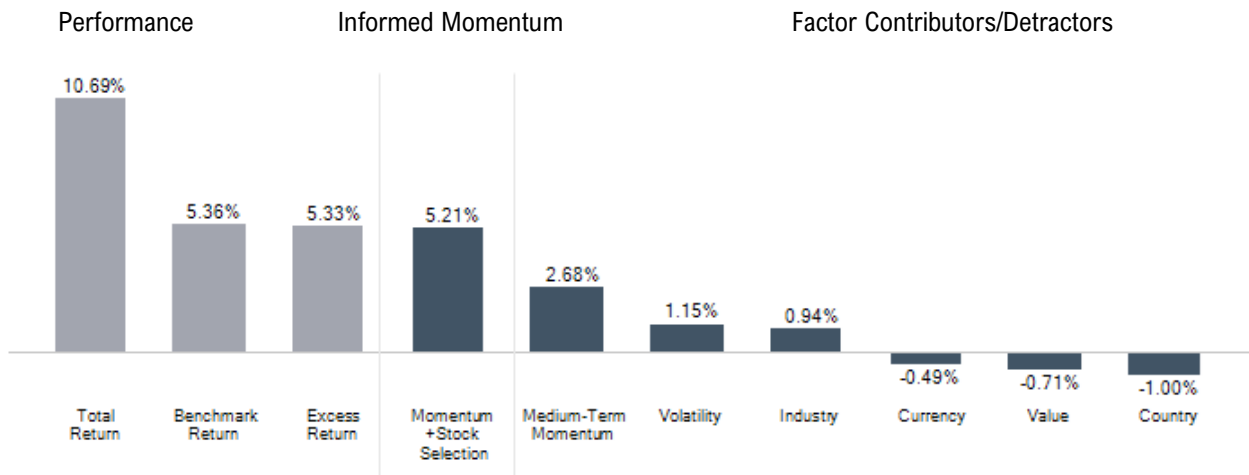
Q3 2025 ATTRIBUTION

Informed Momentum drove outperformance

The IMC Emerging Markets Small Cap strategy gained 10.08% (net of fees) in the third quarter of 2025, outperforming its benchmark by 472 basis points.

- Risk attribution shows Informed Momentum (momentum exposure & stock selection) drove outperformance in the quarter, while exposure to volatility and relative industry positioning was further additive.
- Performance attribution by country shows stock selection contributed most to relative performance, most notably in Taiwan, China, and India.
- Positive allocation effects were driven by being overweight to China and underweight to India.

Q3 2025 Axioma Risk Attribution: IMC Emerging Markets Small Cap vs. MSCI EM Small Cap Index

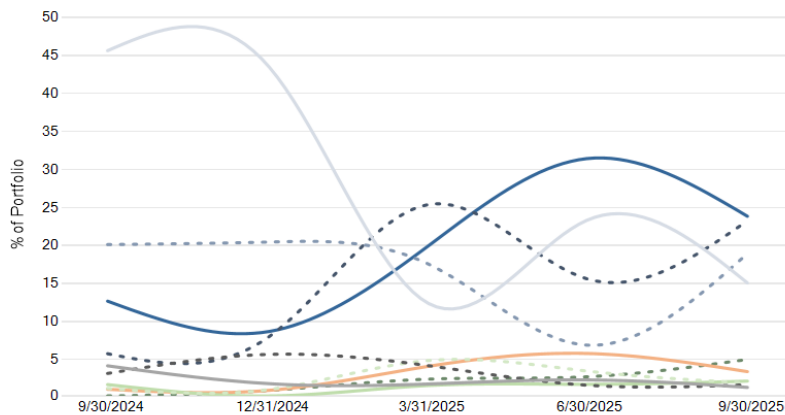


Q3 2025 Performance Attribution: IMC Emerging Markets Small Cap vs. MSCI EM Small Cap Index

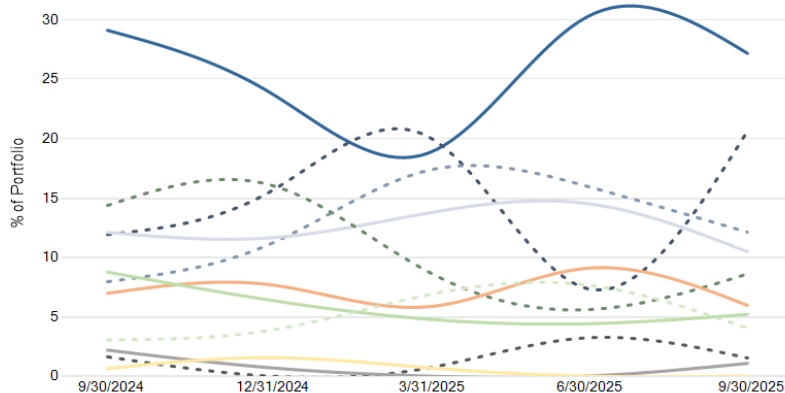
