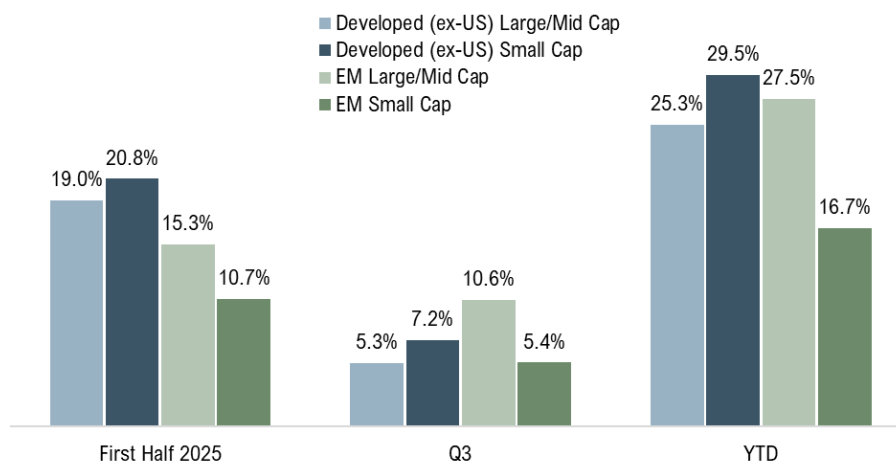

The IMC Non-US Small Cap strategy gained 11.39% (net of fees) in the third quarter of 2025, outperforming its benchmark by 471 basis points. Informed Momentum (momentum exposure & stock selection) drove outperformance in the quarter, while relative industry positioning and exposure to volatility were further additive.

MARKET ENVIRONMENT

Non-US equities extended their gains in Q3 with AI as a dominant theme

- Strength in global equities continues to be underwritten by the AI buildout and everything it touches. The entire AI supply chain is now the dominant macro factor moving markets. Corporate earnings strength and a dovish pivot from the US Federal Reserve served to further boost risk appetite in Q3.
- Emerging markets advanced in the quarter, led by strong gains in China amid progress in US-China trade negotiations. Among developed markets, Japan outperformed as expectations for political reform lifted sentiment, while Canada and Australia benefited from commodities/precious metals tailwinds.
- The MSCI ACWI ex-US Small Cap Index finished the quarter up 6.68%, about on par with its large/mid cap counterpart (MSCI ACWI ex-US), which was up 6.89%. In small cap, hefty exposure to Japan contributed most, while China was the largest driver of returns in the large/mid cap index.



China led gains, while India continued its slide

In the MSCI ACWI ex-US Small Cap Index, China was the best performing country in Q3, up 25.1%, propelled by strength in tech and AI names, and underpinned by signs of progress in US-China trade negotiations. Canada and Australia were also top performers in the quarter, fueled by a strong rally in metals & mining stocks. On the other side, India continued to slide on tariff pressures and a lack of exposure to the AI-driven rally. Europe also failed to keep pace in the quarter as slower export demand and political uncertainty weighed on certain countries.

In non-US small cap, all sectors ended the quarter positive with materials as the standout, up 18.1%, followed by energy (+9.4%) and technology (+8.4%). Consumer staples (+1.5%) and communication services (+2.6%) failed to keep pace.

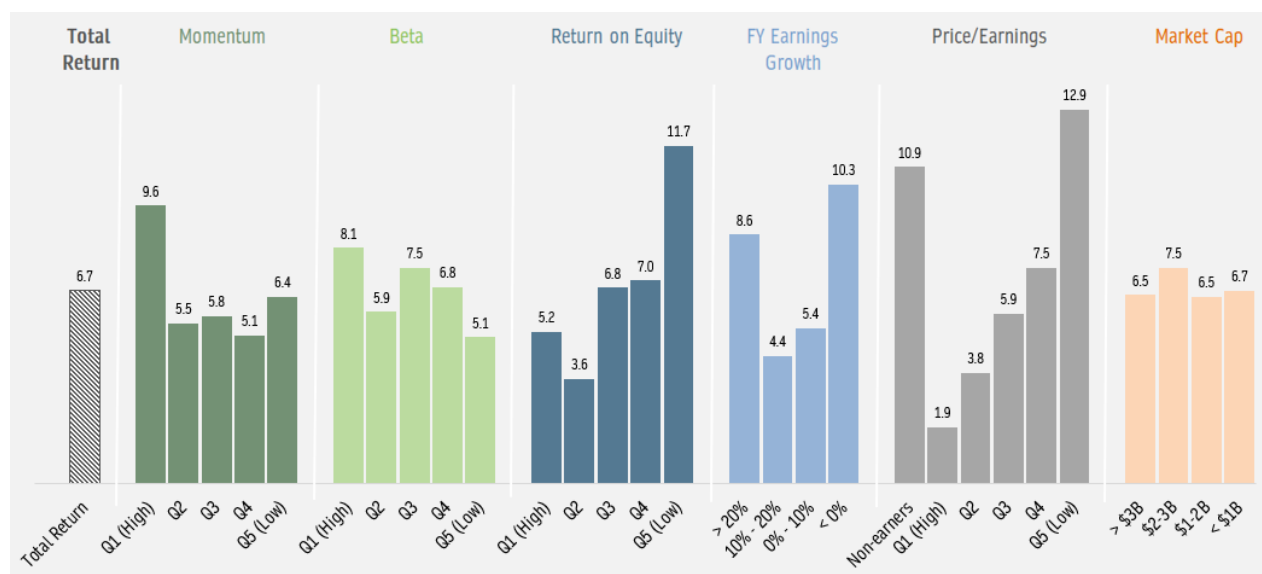

Value stocks were the winners in small cap

From a style perspective, the MSCI ACWI ex-US Small Cap Value Index outperformed its growth counterpart in Q3 by 148bps (7.43% vs. 5.95%). However, looking within the broader index, the dispersion in high vs. low P/E stocks was a distinct theme; the lowest quintile P/E stocks were the best performers, up 12.9% and outperforming the highest P/E quintile by 11 percentage points. Additionally, non-earners, low ROE and high momentum outperformed in the quarter.

Q3 2025 Performance Drivers in the MSCI ACWI ex-US Small Cap Index



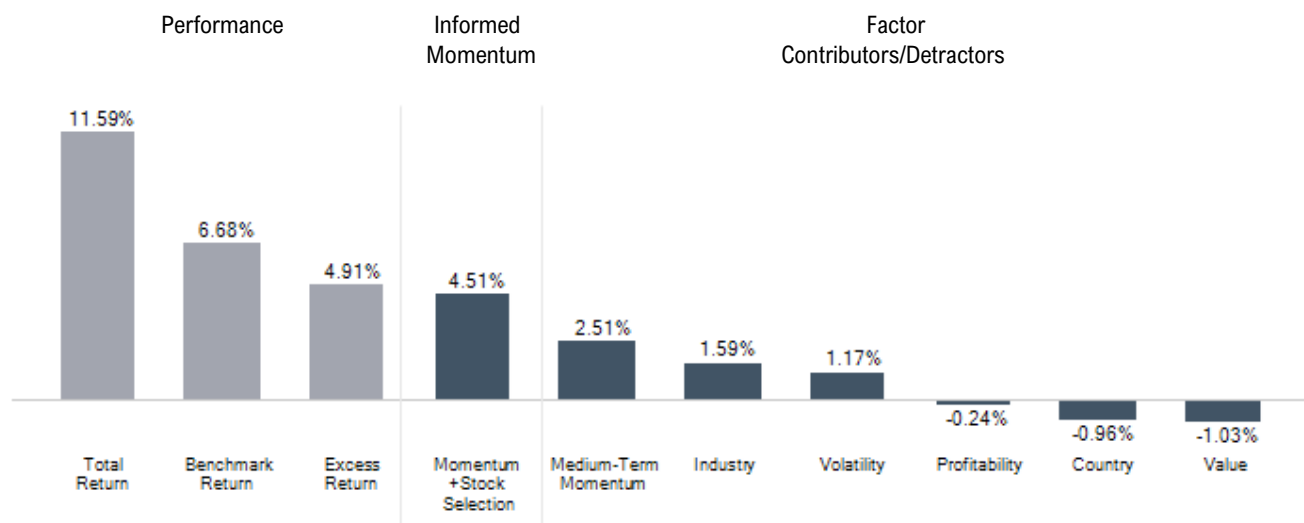
Q3 2025 ATTRIBUTION

Informed Momentum drove outperformance in the quarter

The IMC Non-US Small Cap strategy gained 11.39% (net of fees) in the third quarter of 2025, outperforming its benchmark by 471 basis points.

- Risk attribution shows Informed Momentum (momentum exposure & stock selection) drove outperformance in the quarter, while relative industry positioning (overweight tech and aerospace & defense, and avoiding real estate) and exposure to volatility were further additive.
- Performance attribution by country shows stock selection contributed most to relative performance, most notably in Taiwan, Italy, and Australia. This was offset partially by negative stock selection in Korea.
- Positive allocation effects were driven by being overweight to China and Australia and underweight to the UK.

Q3 2025 Axioma Risk Attribution: IMC Non-US Small Cap vs. MSCI ACWI ex-US Small Cap Index

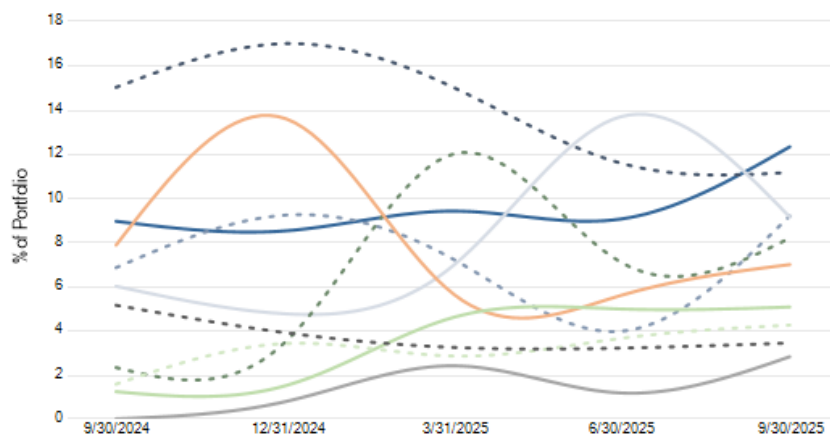


Q3 2025 Performance Attribution: IMC Non-US Small Cap vs. MSCI ACWI ex-US Small Cap Index

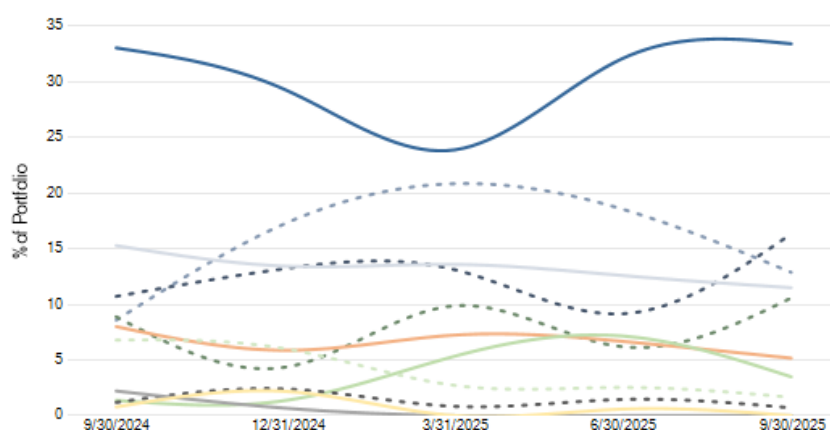
