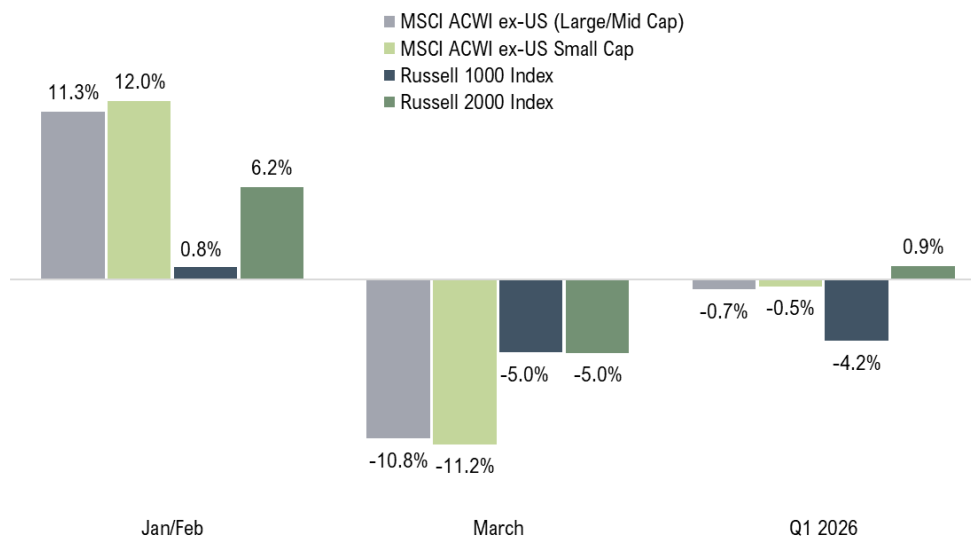

The IMC Global Small Cap strategy gained 10.07% (net of fees) in the first quarter of 2026, outperforming the MSCI ACWI Small Cap Index benchmark by 901 basis points. Informed Momentum (momentum exposure & stock selection) drove outperformance in the quarter, while relative industry positioning (overweight technology and industrials) was further additive.

MARKET ENVIRONMENT

March selloff erased a strong start to 2026

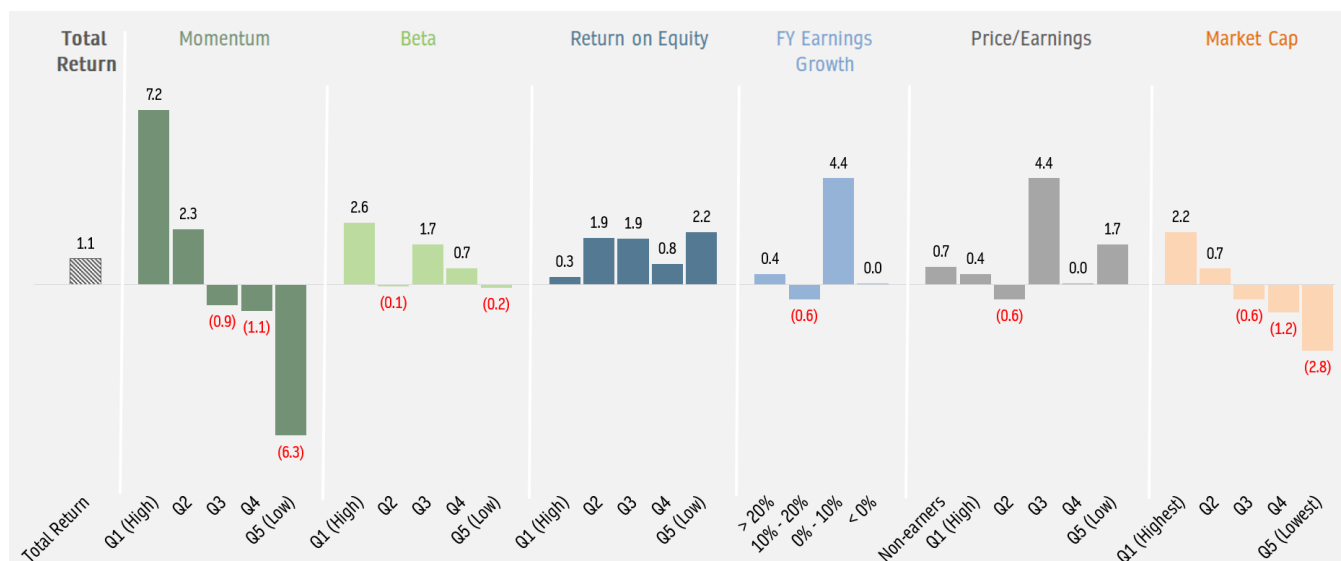
- It was a strong start to the year for global equities, with the AI investment cycle as a key structural tailwind. Within technology, performance became increasingly bifurcated, as investors favored AI-enabling areas such as semiconductors, cloud platforms, and data center infrastructure, while pulling back from more traditional software names amid uncertainty around the long-term implications of generative AI on established business models.
- In March, the conflict in the Middle East took center stage, increasing uncertainty for the global economy and triggering a broad-based selloff. Countries most impacted by higher energy costs and supply chain disruptions were hardest hit, while the US held in relatively well. Higher oil prices drove energy stocks to be the standouts in the quarter.
- The MSCI ACWI Small Cap Index managed to eke out a gain of 1.06% in Q1, pulling further ahead of its large cap counterpart, which declined 3.71%. Small cap's outperformance has been particularly notable in the US - supported by improving market breadth, increased investor appetite for idiosyncratic opportunities, and reduced concentration in mega cap leadership.



Momentum was a clear theme

According to Axioma, momentum held in well even through March to end the quarter as the best performing factor in global equity markets. Within the MSCI ACWI Small Cap Index, higher momentum stocks outperformed in linear fashion with the top momentum quintile gaining 7.2% in Q1. At the same time, stocks with higher beta, lower ROE and higher market cap also fared best in the quarter.

Tech-driven markets led gains

In the MSCI ACWI Small Cap Index, technology-oriented markets were among the best performing countries in the quarter, including Korea (+12.3%), Taiwan (+10.1%) and Israel (+7.5%). Canada (+7.1%) also outperformed, benefiting from heavy exposure to energy and materials amid rising commodity prices. On the downside, India (-18.5%) continued to be a notable drag amid persistent macro headwinds and sensitivity to oil prices.

At a sector level, energy was the standout performer, up 32.3% in Q1, followed by utilities (+7.2%) and technology (+6.7%), while consumer discretionary (-7.4%), communication services (-4.8%) and real estate (-4.3%) lagged.

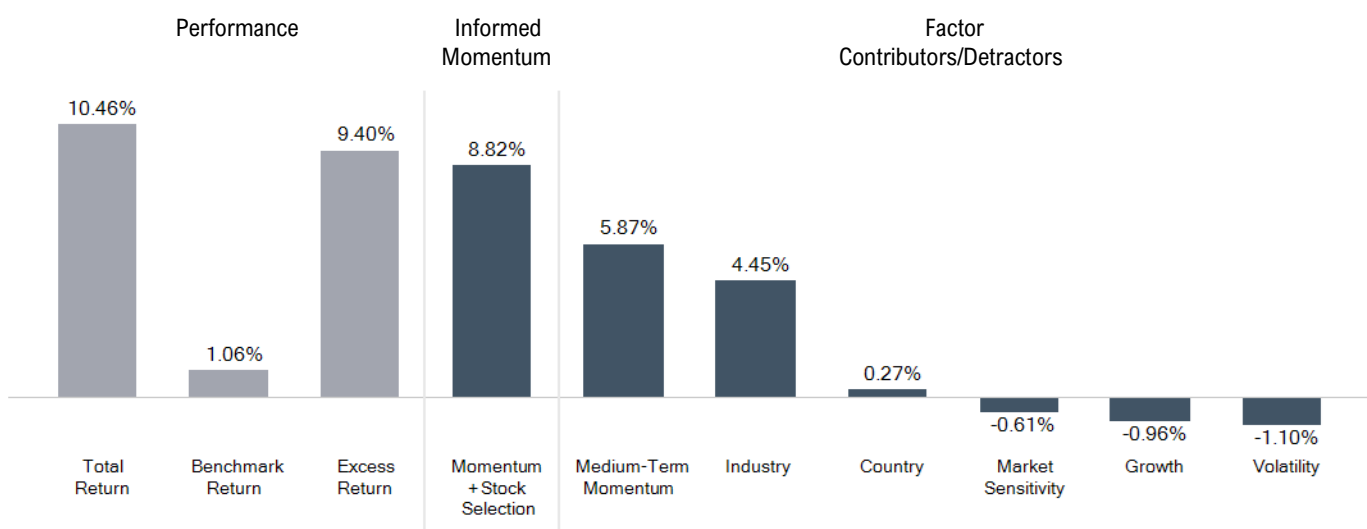
Q1 2026 ATTRIBUTION

Informed Momentum drove outperformance in Q1

The IMC Global Small Cap strategy gained 10.07% (net of fees) in the first quarter of 2026, outperforming the MSCI ACWI Small Cap Index benchmark by 901 basis points.

- Risk attribution shows Informed Momentum (momentum exposure & stock selection) was the primary driver of outperformance in the quarter.
- Relative industry positioning (overweight technology and industrials) and country positioning (underweight India) were further additive, while exposure to volatility, growth, and market sensitivity detracted.
- Performance attribution shows stock selection contributed most, particularly in the US, Israel and Taiwan. Allocation effects were also positive with an underweight to India being most beneficial.

Q1 2026 Axioma Risk Attribution: IMC Global Small Cap vs. MSCI ACWI Small Cap Index



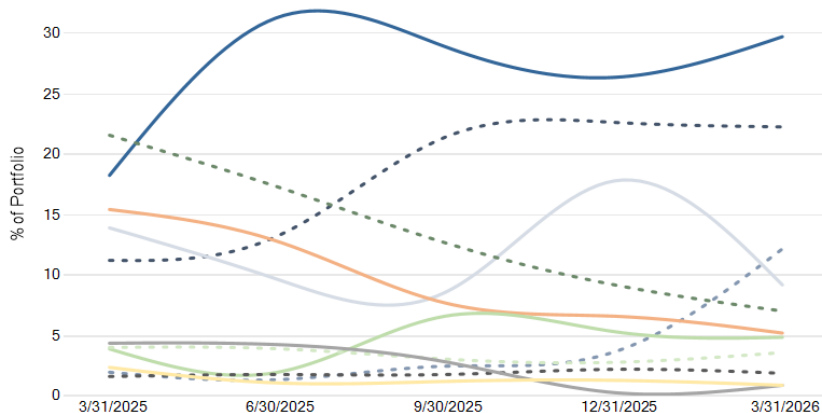
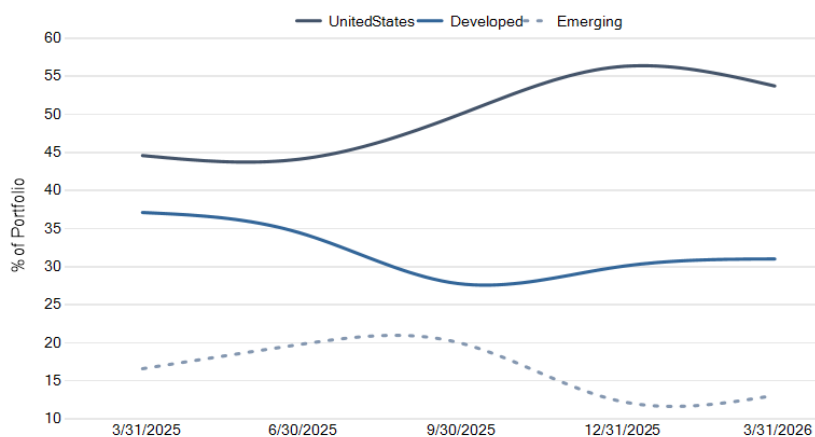
