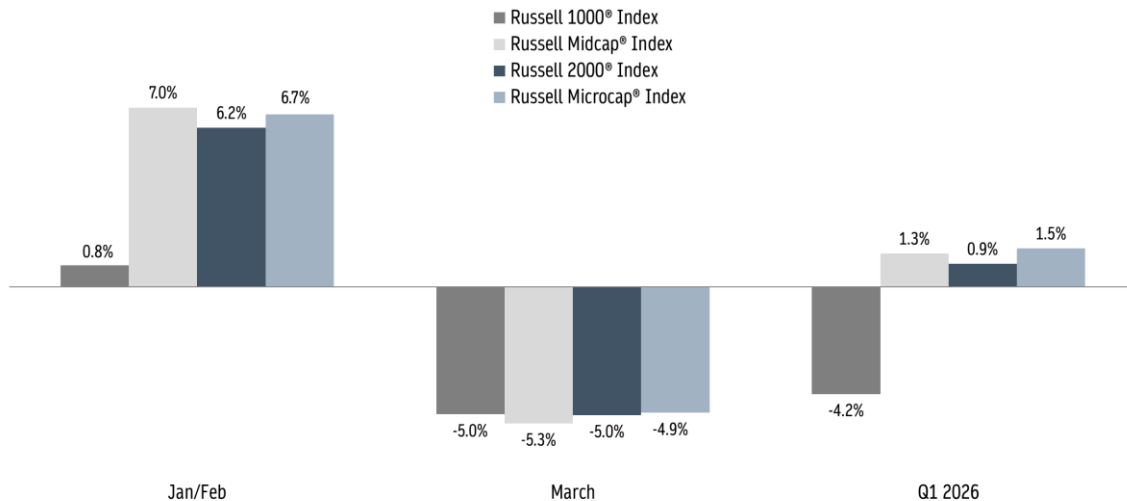

The IMC US Micro Cap strategy gained 2.69% (net of fees) in the first quarter of 2026, outperforming the Russell Microcap Index by 120 basis points and outperforming the Russell Microcap Growth Index by 694 basis points. Informed Momentum (momentum + stock selection) was the largest contributor to outperformance in the quarter, while industry positioning (overweight technology and energy, underweight financials) was further additive.

MARKET ENVIRONMENT

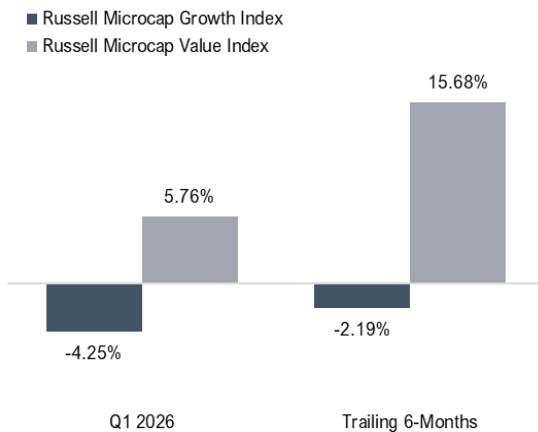
A volatile start to 2026, with leadership continuing to broaden

- It was a strong start to the year for US equities—outside of mega cap. Easing inflation and resilient economic data supported a continued rotation into smaller, more cyclical firms, while mega cap technology remained under pressure amid concerns around AI-related excesses. A growing divide within technology emerged as AI-linked infrastructure continued to advance while software saw a sharp re-rating.
- In March, the conflict in the Middle East took center stage, increasing uncertainty for the global economy and triggering a broad-based selloff. Higher oil prices drove energy stocks to lead for the quarter, while a more gradual path for rate cuts reinforced the appeal of shorter-duration, economically sensitive businesses—resulting in meaningful value outperformance versus growth.
- Micro cap extended its lead in Q1, gaining 1.49% and outperforming other size segments. Micro cap has delivered a strong run of performance that started with last year’s beta-driven rebound – for the trailing 1-year period, the index is up 45.8%, beating small cap (+25.7%) and large cap (+17.7%), supported by improving market breadth, increased investor appetite for idiosyncratic opportunities, and reduced concentration in mega cap leadership.



Value made strong gains in the quarter

The Russell Microcap Value Index rose 5.8% in Q1, outperforming Growth by more than 10 percentage points. Value gains were led by energy’s leadership, as the sector was up 19.3% in the Russell Microcap Index, while real estate (+8.3%) and industrials (+5.4%) also outperformed. Sticky inflation and a more gradual path for rate cuts reinforced the relative appeal of shorter-duration, economically sensitive businesses, while expensive growth stocks faced multiple compression. At the same time, we saw a growing split within technology as the AI industrial complex continued to churn higher while software was massively rerated. Within the micro cap index, semis and communications equipment was up over 30% in Q1, while software was down 11.8%.



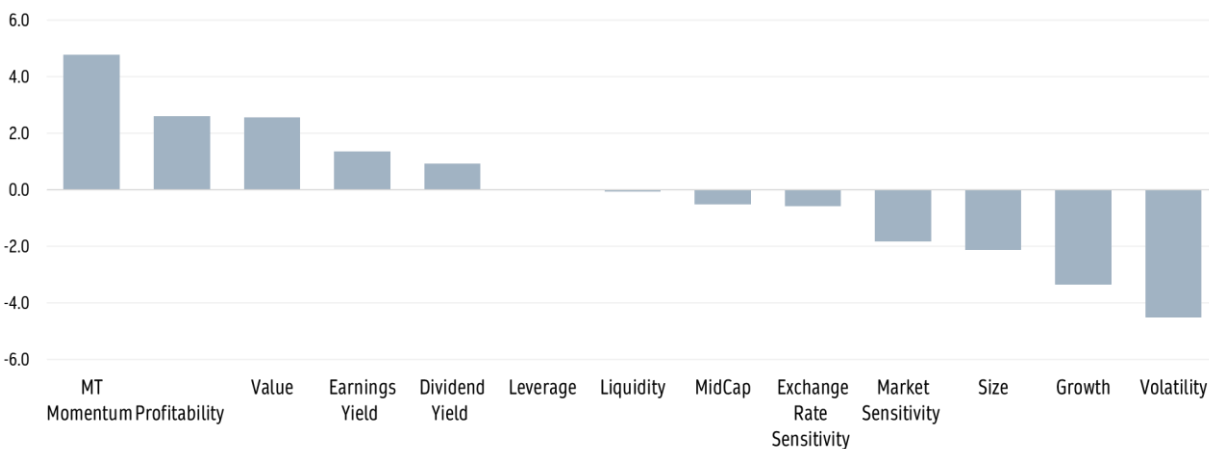

Momentum was a tailwind for US equities, but less so in micro

According to Axioma, momentum held in well even through March to end the quarter as the best performing factor in US equity markets. Within large, mid and small cap indices, higher momentum stocks were consistently the best performers. However, within the Russell Microcap Index, performance was mixed with the highest momentum quintile lagging the total index return. Within micro cap, it was stocks with the highest earnings growth and lowest beta that did best, while the lowest ROE stocks were the standouts on the downside.

Axioma US Equity Factor Performance – Q1 2026



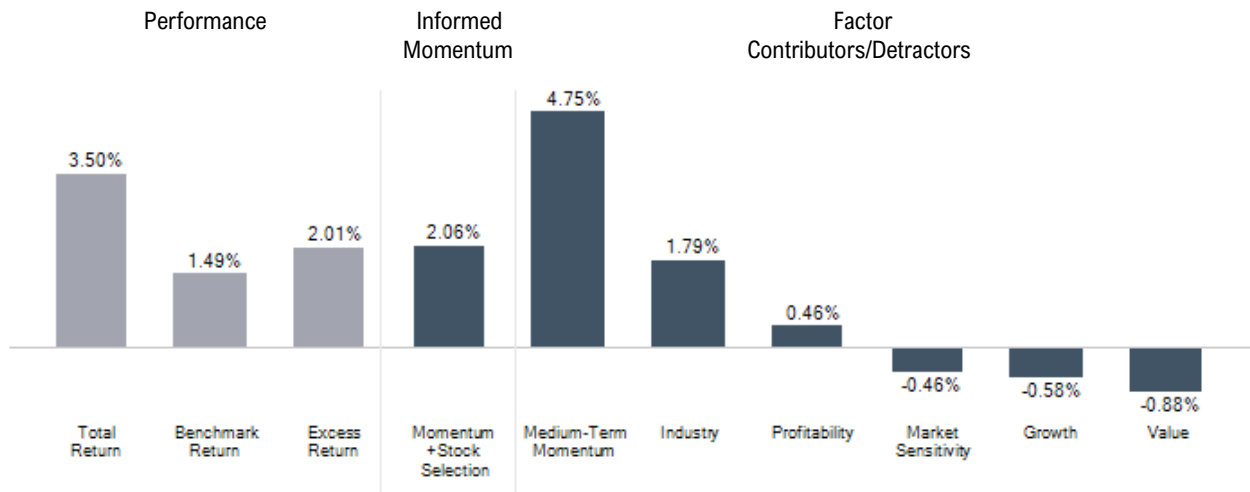
Q1 2026 ATTRIBUTION

Informed Momentum drove outperformance in Q1

The IMC US Micro Cap strategy gained 2.69% (net of fees) in the first quarter of 2026, outperforming the Russell Microcap Index by 120 basis points and outperforming the Russell Microcap Growth Index by 694 basis points.

- Risk attribution shows Informed Momentum (momentum + stock selection) was the largest contributor to outperformance in the quarter. Relative industry positioning (overweight technology and energy, underweight financials) was further additive, while underexposure to value and exposure to growth detracted.
- Performance attribution shows stock selection in technology, industrials and communication services was most additive, offset partially by negative effects in health care and materials.
- Allocation effects were negative due mostly to being overweight health care earlier in the quarter.

Q1 2026 Axioma Risk Attribution: IMC US Micro Cap Composite vs. Russell Microcap Index

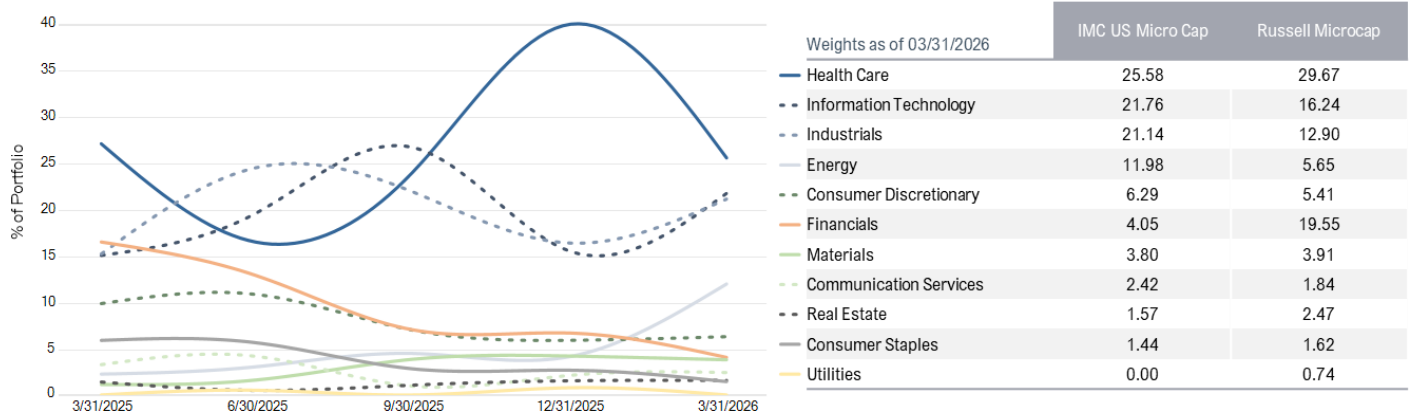
